****PART 2: SITE REQUIREMENTS****

The following must be confirmed BEFORE the event date. McQueen Augusta reserves the right to cancel without refund if requirements are not met on arrival.

****☐****	****Space:** ****Minimum 20 x 20 foot flat, open outdoor area (grass, concrete, or pavement)**
****☐****	****Water:** ****Standard garden hose connection accessible within 100 feet of foam setup area**
****☐****	****Power:** ****Standard 110V electrical outlet accessible within 100 feet of foam setup area**
****☐****	****Access:** ****Clear, unobstructed path for equipment to be carried in/out (no locked gates, low wires, or narrow passages)**
****☐****	****Drainage:** ****Area has natural drainage – standing water should not pool directly under setup area**
****☐****	****Approval:** ****HOA or property management approval obtained by client if required**
****☐****	****Surface:** ****No sharp debris, rocks, or hazards in the foam area that could injure participants**

****PART 3: PARTICIPANT SAFETY GUIDELINES****

Please share these guidelines with all guests and participants before the foam starts.

- All participants should wear swimwear or clothes they do not mind getting wet and soapy.
- Remove shoes before entering the foam area. Bare feet or water shoes are recommended.
- Participants with open wounds, skin sensitivities, or known soap allergies should not enter the foam.
- Notify McQueen Augusta staff of any allergies or health concerns before the event begins.
- Keep foam out of eyes and mouths. Rinse with clean water immediately if contact occurs.

- No running inside the foam area. Surfaces may be slippery.
- An adult supervisor must be present and visible at all times during the foam party.
- Pets should be secured away from the foam area for their safety.
- Children under 5 should be supervised directly by a parent/guardian inside the foam area.
- Cell phones and electronics should be kept a safe distance from the foam area.

****PART 4: WHAT McQUEEN AUGUSTA PROVIDES****

- Professional foam cannon setup and operation by trained McQueen Augusta staff
- Non-toxic, biodegradable, skin-safe foam solution (included in service price)
- Full setup and full breakdown/cleanup of all equipment
- Safety briefing for participants before foam begins
- Approximately 1 hour of active foam time per booked session

****PART 5: WHAT THE CLIENT PROVIDES****

- A venue meeting all site requirements listed in Part 2
- Access to a working water hose hookup on event day
- Access to a working 110V electrical outlet on event day
- An adult supervisor present for the duration of the foam party
- Signed Service Agreement and Media Release Form returned before or on the event date
- Remaining balance paid in full on or before event day

****PART 6: IMPORTANT NOTES****

****⚠ Weather Policy**** Foam parties are outdoor events. McQueen Augusta monitors weather conditions and will notify clients of any weather-related concerns. In the event of severe weather (lightning, heavy rain, high winds), the event may be rescheduled at no penalty. ☔ Light rain does not automatically cancel the event. McQueen Augusta will use discretion on a case-by-case basis. ****⚠ Slippery Surfaces**** Foam parties create wet, soapy surfaces. McQueen Augusta strongly recommends non-slip footwear for all adult supervisors and cautions all participants about slippery conditions. Client assumes responsibility for participant safety and behavior in the foam area.
