****SECTION 3: PAYMENT TERMS****

- A non-refundable deposit of \$75.00 is required to confirm and hold your booking date.

- Remaining balance is due in full on or before the day of the event.

- Accepted payment methods: Cash, Credit/Debit Card (via Square), Cash App, Zelle.

- Returned payments or declined cards may result in automatic cancellation and forfeiture of deposit.

****SECTION 4: CANCELLATION *****&***** RESCHEDULING****

- Cancellations made 7 or more days before the event date: deposit is forfeited, no additional charge.

- Cancellations made within 72 hours of the event: 50% of the total balance is due.
- Same-day cancellations or no-shows: full payment is due.
- McQueen Augusta reserves the right to cancel due to severe weather or equipment malfunction. A full refund or reschedule will be offered at no penalty to the client.
- Rescheduling is allowed once at no charge with a minimum of 48 hours notice, subject to availability.

****SECTION 5: SITE ***** VENUE REQUIREMENTS****

Client is responsible for ensuring the event location meets the following minimum requirements before the event date. Failure to meet these requirements on the day of service may result in cancellation without refund.

****Required Site Conditions**** • Minimum 20 x 20 foot flat, open outdoor space (grass, concrete, or pavement) • Access to a standard garden hose water connection within 100 feet of setup area • Access to a standard 110V electrical outlet within 100 feet of setup area • Clear path for equipment access and setup (no gates with locks, low-hanging wires, or obstructions) • Confirmation of HOA or property approval if applicable

****SECTION 6: CLIENT RESPONSIBILITIES ***** SAFETY****

- All participants must be in appropriate attire (swimwear, shorts, or clothes the client does not mind getting wet and soapy).
- The foam solution used is non-toxic, biodegradable, and skin-safe. Client assumes responsibility for notifying McQueen Augusta of any known allergies before the event.
- Participants with open wounds, skin conditions, or sensitivities should refrain from foam participation.
- McQueen Augusta is not liable for any personal injury, property damage, or loss resulting from participant behavior or failure to follow safety instructions.
- An adult supervisor must be present at all times during the foam party. McQueen Augusta staff will operate the equipment only.
- Pets should be secured away from the foam area for their safety and the safety of participants.
- Client is responsible for any damage to property caused by failure to provide adequate drainage space.

****SECTION 7: LIMITATION OF LIABILITY****

McQueen Augusta (Tatty LLC) shall not be held liable for injury, loss, or damage arising from: acts of nature, power outages, equipment malfunction beyond our control, or client/participant failure to follow safety instructions. Total liability shall not exceed the amount paid for services under this agreement.
